The 270XL will initially be offered in two floor plans: a twin bed (270XL TB) and a

twin sofa (270XL TS). The new models are currently under development for availability later this year.

What's In Your Wallet?

We have all heard horror stories about identity theft. We are happy to pass along a good idea that can help you recover and limit the damage should your wallet be lost or stolen.

Place the contents of your wallet on a photocopy machine, and make copies of both sides of each license, credit card, etc. You will know what you had in your wallet, plus the account numbers and phone numbers to call and cancel. Leave one copy at home or with a family member, and place another copy somewhere in your RV.

If such loss does occur there are several steps that should be taken. Call and cancel your credit cards, file a police report *immediately*, call the three national credit reporting organizations to place a fraud alert on your name and Social Security number, and notify the Social Security Administration.

The numbers to call are as follows: Equifax, 1-800-525-6285; Experian, 1-800-397-3742; Trans Union, 1-800-680-7289; Social Security Administration, 1-800-269-0271.

This information has been making the rounds on the Internet lately. I received it from several sources, including Bern Wolsky.

Saturday morning a breakfast of juice, muffins and coffee will be served; lunch is on your own. The day will be devoted to visiting with friends, swapping travel tales (and some tall tales) and just general relaxation. Dinner is at 5 p.m., followed by a Yankee swap meet at 7 p.m.; please bring a wrapped gift not to exceed a \$10 value. Those who were at Tarpon Springs will remember all the fun we had at that swap meet.

On Sunday morning, we will gather for a pancake breakfast before departing for home or whatever destination calls you.

Please have your reservation and fees in by March 29!

The rally fee is \$65 for two per coach and \$45 for one. A registration form is on the back page of this newsletter. Make your checks payable to CHOC and mail to Pauline Stevens. You *must* reserve your own campsite; call (386)397-1677 and mention that you are with the Coach House Owners Club in order to obtain the special rally fee of \$14 a night.

Directions: From I-75, take exit 84, go east on S.R. 136 for 2.5 miles to White Springs Road; turn south 0.2 mile to Steven Foster Road, turn left and go 0.5 mile to the campground. There are signs to the campground at each of the turns.

Fall Rally: Sept. 22–26, 2002

Juan and Peggy Galvez are our hosts for the CHOC Fall Rally in Bay St. Louis, Miss. We will be staying at the Casino Magic RV Park, right next door to the casino and restaurants. The park offers full hookups, level concrete pads, cable TV, barbecue grills and 24-hour security.

There is a full schedule of activities planned, as well as plenty of time to visit the casinos to try your luck or take in a show. We will arrive on Sunday with a special welcome dinner scheduled for 5 p.m. A bus will be available on Monday and Tuesday to allow a visit to historic Bay St. Louis. Also on Tuesday, a Gray Lines tour of New Orleans will be available for an additional cost of \$36 per person. There is plenty to do and see in this area, so wear comfortable shoes and bring along your camera. The rally will conclude on Thursday morning with a light breakfast.

demonstration of the value of these seminars.

We were attracted by a glare outside our window, which turned out to be a fire in the diesel heating plant of one of the huge Monacos. Flames spewed from the heater exhaust pipe, looking very much like the TV ad in which a man wakes up with heartburn and lets loose with a blow-torch like flame from his mouth. Fortunately the owner cut off the fuel supply and extinguished the flames with a towel. The very next day we attended an outdoor fire safety demonstration that showed exactly how such a fire

should be extinguished and which type fire extinguisher was best. The demo leader had several of the older onlookers, male and female, actually put out similar fires. Smaller foam-type extinguishers then were available for purchase at a deeply discounted price of \$5.

This FMCA rally was also an opportunity to get some repair work done on malfunctioning appliances by the manufacturers' representatives, or to buy some new accessories for the RV.

All in all, response to this rally was very favorable. We for one are going to attend the big Annual Winter FMCA Convention being held in Perry, Ga., in late March. Come one, come all.
