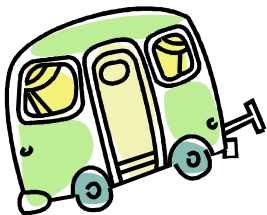

Trip to Albuquerque Balloon Fiesta

Our trip started on September 9th. We went to Rocky Mts. National Park where it was very cold at night. It was elk rutting season where the bucks bugle most of the night. We came south and visited the Air Force Academy; it was Sunday so very quiet there, no tours. The next day we had a tour of Coors Brewery and a few samples. The Zima tangerine was really good.

We continued south to the Great Sand Dunes National Park in southeast Colorado, we were there a few years ago and found we could not hike as much as on our previous visit.

The next stop was for a train ride on the narrow track Cumbre & Toltec RR. The train went through the mountains where the quaking aspens were in full color. The train crossed the Colorado New Mexico border 13 times and reached an elevation of 10378 ft. A buffet lunch was served at the top of the mountain.

Then it was on to Bandolier National Monument in NM. This is a small park near Los Alamos, was home to Indians a long time ago and they mostly lived in caves. It was National Park appreciation weekend so admission was free. Since we have Golden Age Passports we would not have had to pay. There were many Native craft people there also dance demonstrations. The campground was very quiet, on Sunday night there was only the hosts and us.

We continued south to Sante Fe and walked around the Plaza. There were many Native vendors; the jewelry was more expensive than two years ago. We visited the Loretto Chapel. This is the Chapel with the spiral staircase built without nails or screws, amazing!

At last it was on to Albuquerque. We stayed at the American RV Park where we were able to get ready to go to balloon park, we did laundry etc. this was a very nice park with swimming pool and a free breakfast. We then went to Balloon Park (this is dry camping), we had a nice site away from the big rigs nothing in front of us except a fence. We were about ½ mile from the launch sites, a free shuttle went to the park starting at 5.30 AM the shuttle also ran in the evening for the activities, it was also within walking distance. Saturday morning was the start of the fiesta, with a mass ascension of about 500-600 balloons this took 2 hours. It was a sight that has to be seen in person to really appreciate it. We were able to walk around the balloons while they are being prepared for launch.

It rained Saturday afternoon and night, the night glow and Sunday morning ascension were cancelled. Sunday night the rain had stopped the glow was held, this is when the balloons are tethered and lit up inside, spectacular! Walking among the balloon was great and quite warm. Pictures do not do it justice. Monday night the gas balloons (hydrogen & nitrogen) were prepared for launch, they were all white and took off after dark, when launched they looked like huge jellyfish. These balloons will be in the air for up to 80 hours and travel to various destinations, so we were told by the pilots who came from many different countries.

Tuesday morning many balloons came over the campground and landed between the RV's they were playing a game which was trying to pick items up from the ground. There were balloons all over the campground, amazing. We then started on our trek home; we met with our CHOC friends Freddie and Ann Lott in Augusta for lunch then continued home. We had traveled 4980 miles.
